AN ORDINANCE DECLARING AN EMERGENCY AND GRANTING NON-CONFORMING STATUS TO ALL EXISTING SIGNS ON PROPERTIES IMPACTED BY THE CLEVELAND-MASSILLON ROAD WIDENING PROJECT, PHASES 2 AND 3, AND DECLARING AN EMERGENCY.
