CHARTER REVIEW COMMISSION
Wednesday, May 31, 2006

The Charter Review Commission of the City of Norton, Ohio, convened for a public meeting in Norton City Council Chambers. Chairperson Barbara Vimont called the meeting to order at 6:30 p.m.

I. ATTENDANCE:

ABSENT: Gene Becker, Charles Campbell

II. CONSIDERATION OF MINUTES:

A.) Wednesday, May 3, 2006:

The Commission reviewed the minutes from their Wednesday, May 3, 2006, meeting and Chairperson Vimont called for a motion. **Ms. Megan Booth moved to approve the minutes of Wednesday, May 3, 2006, as submitted; seconded by Mr. Robert Daymut. ROLL CALL: Ms. Booth -Yea, Mr. Daymut-Yea, Ms. Sue Ringkor-Yea, Mr. Christopher Judge-Yea, Ms. Vimont-Yea. The motion passed 5-0, approving the minutes as submitted.**

III. OLD BUSINESS:

A.) Review recommendations made.:

The Commission reviewed CRC Resolution No.'s 01-2006 and 02-2006. Chairperson Vimont announced that they were scheduled to be discussed at the Committee of the Whole meeting on Monday, June 5, 2006, at 7:00 p.m. She suggested that it would be a good idea for the members of the Commission to be present if possible in case the Committee of the Whole has questions.

IV. NEW BUSINESS:

A.) Decide next section to review.:

Chairperson Vimont asked for suggestions as to what Charter section they should review next. After discussion, the Commission agreed to continue with Article V-Administrative Departments, starting with Section 5.03(c).

The Commission asked the Secretary to check with Ms. Karla Richards, Clerk of Council regarding the first election date in 2007, and the deadline for registering for an issue to be placed on a ballot. She said she would.

B.) Comprehensive Plan Citizens Working Group (CPCWG):

Ms. Booth informed the Commission that the next CPCWG meeting was scheduled for Thursday, June 8, 2006, at 7:00 p.m. in the Shirley L. McGuire Community Center Ballroom. After discussion, the Commission decided that it would be informative to them to attend those meetings when possible.

C.) Norton Website:

Mr. Daymut stated that he did not think Norton residents accessed the Norton website enough. The Commission wondered if the website address could be advertised in the local newspapers and/or posted in the Norton Library. They requested the Secretary check into this matter and ask Ms. Ann Campbell, Website Master, for a unique count of visitors to the website. She said she would.

V. ADJOURNMENT:

Chairperson Vimont announced that the next meeting was scheduled for Wednesday, June 7, 2006, at 6:00 p.m. They will continue the review of Article V-Administrative Departments, starting with Section 5.03(c) at that time. With no further business coming before the Commission, Chairperson Vimont adjourned the meeting at 6:57 p.m.

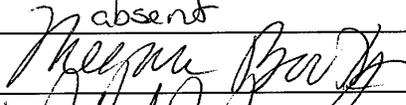
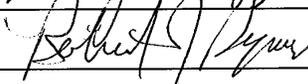

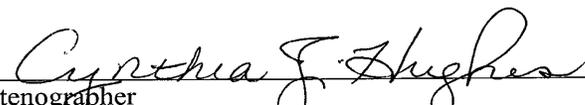
