III. NEW BUSINESS:


IV. OLD BUSINESS:

He stated that we have had MAD give their presentation and we would like to see SCHD put together a presentation of what they have to offer as far as mosquito control. He stated that would be the only way we could go if we want to do a resolution. Ms. Whipkey stated that the only way she knows SCHD comes out is if you call them to spray. She stated that they do not have a schedule for spraying. Mr. Safron stated that he checked the website and stated he saw that they usually spray once a month. He would like to try and get the department to come back and explain what they do and Ms. Whipkey stated that they would be discussing the MAD at the July 2, 2012 meeting. There was a discussion concerning when the last time Summit County Health District was here to talk about the mosquito plans. Mr. Safron stated that from the website and what was said before is inconsistent. Ms. Whipkey stated that with MAD spraying would interfere with any pattern that they would have. Ms. Whipkey stated that SCHD stated that they would not come out if we have MAD. Ms. Fisher stated she would contact SCHD and see if they could come out on July 5th to have a Norton Health Advisory Board meeting then to discuss it.


