CITY OF NORTON RESOLUTION NO. 15-2017

A RESOLUTION CONFIRMING THE APPOINTMENT OF ANDREW MULLINS TO A THREE-YEAR TERM AS AN AT LARGE REPRESENTATIVE ON THE CITY OF NORTON BOARD OF ZONING & APPEALS, AND DECLARING AN EMERGENCY.

WHEREAS, Mayor Zita has appointed Andrew Mullins to a three-year term as an At Large representative on the City of Norton Board of Zoning and Appeals, which term commences on March 1, 2017 and expires February 29, 2020; and

WHEREAS, such appointment must be confirmed by Council.

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of Norton, Counties of Summit and Wayne, and State of Ohio:

- Section 1: The appointment of Andrew Mullins as an At Large representative on the City of Norton Board of Zoning and Appeals for a three-year term commencing on March 1, 2017 and expiring February 29, 2020, is hereby confirmed.
- Section 2: All formal actions of this Council related to this Resolution and all deliberations of the Council and of any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- Section 3: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation for the public peace, health and safety of the City of Norton and the inhabitants thereof for the reason that the subject appointment is necessary for the prompt resolution of City affairs, and provided that this Resolution receives the affirmative vote of two-thirds of the members of Council, it must take effect and be in force immediately upon its passage and approval by the Mayor; or otherwise, it will take effect and be in force at the earliest period allowed by law.
