**ORD # 50-2016**

Mr. Tousley offered Ord. #50-2016 for its second reading and asked the Clerk to read it:

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE AND DELIVER FINAL FINDINGS AND ORDERS TO THE DIRECTOR OF THE OHIO EPA FOR THE NASH HEIGHTS AREA, AND DECLARING AN EMERGENCY.

Second reading only. Mr. Tousley stated he assumed the reason for this Special was so that we could get a second reading. Ms. Whipkey concurred unless we wanted to waive the third and go ahead as we really have no choice in the matter. Mr. Markey stated it is preferred to move this along and adopt but this is Councils decision. Ms. Whipkey stated this does not change what we have to do, and it keeps us in good standing. Ms. Whipkey asked if we are still on schedule? Mr. Markey stated he believed so. When we talked with the EPA we indicated this would be going through our legislative process, so obviously the sooner the better. Mr. Kernan moved to waive the third reading, seconded by Ms. Whipkey.
