INTRODUCTION OF NEW LEGISLATION:

ORD #43-2011

Mr. Braman offered Ord. #43-2011 for its first reading and asked the Clerk to read it:

AN ORDINANCE TO AMEND SECTION 858.06 OF TO THE CODIFIED ORDINANCES OF THE CITY OF NORTON, OHIO; AND DECLARING AN EMERGENCY.

Mr. Braman moved to suspend the second and third readings, seconded by Mr. Nicolard. Mr. Bergstrom stated that he was opposed to suspending the readings. He is not opposed to having a regulated plan or businesses moving into Norton, he just is cautious of moving too fast. Mr. Mowery agreed with Mr. Bergstrom being against waiving the readings. Mr. Mowery thanked Mr. Kostoff for all of his time and effort he has put into this and educating all of us on this matter. Mr. Nicolard stated that he has been all over the board on this issue and has come full circle on it. Mr. Nicolard stated he has come to the point that the sooner we have this in place the better off we all will be.
