1. To approve the contract amendment with Perrin Asphalt and Concrete for the 2023 Road Program in the amount not to exceed \$422,274.69.

Mr. Turske said it is going to be real close so instead of coming back to council we would like to have \$5,000 put on the contract. He said we will monitor it and this way it will cover us throughout the duration. Mr. Tousley asked Mr. Turske to keep them informed of the situation. Mr.

DeHarpart asked if the \$5,000 is in addition to the \$422,000 in work. Mr. Turske answered that it is an additional 5.

Mr. DeHarpart made a motion to approve. Mr. Tousley seconded.

Mayor Zita stated that the \$5,000 is just in case we need it.
